In 2003, the United Nations (UN) adopted the Globally Harmonized System of Classification and Labeling of Chemicals (GHS). GHS includes criteria for the classification of health, physical and environmental hazards, as well as specifies what information should be included on labels of hazardous chemicals, as well as safety data sheets. The United States was an active participant in the development of GHS, and is a member of the UN bodies established to maintain and coordinate implementation of the system.

With the implementation of GHS in the United States, labeling requirements for hazard communication and transportation can be confusing.

Learn how hazard communication and transportation labeling requirements are similar and how they are different.

Learn how to apply the requirements to be compliant with both U.S. Department of Transportation (DOT) and Occupational Safety and Health Administration (OSHA) regulations.

This webinar focuses on labeling for shipped containers and does not address alternative workplace labeling as defined by OSHA.
