Our virtual events including the **YEP Summit** and **Webinars** attracted **2,613 Attendees** from more than 40 countries and 47 states in 2023.






We had more than 175,000 impressions of our content on the Safe Hydrogen Project LinkedIn spotlight page.

# **CO2 Solutions Coalition**

In 2023 CGA led an effort to form a coalition to defend the CO2 supply chain against the unintended consequences of proposed and enacted legislation and regulations.

The CO2 Solutions Coalition's members now include The Compressed Gas Association (CGA), Gas and Welding Distributors Association (GAWDA), American Beverage Association (ABA), and International Beverage Dispensing Equipment Association (IBDEA) with participation from more than 10 other industry groups representing the end users of CO2.

# Federal Helium Reserve

The Compressed Gas Association (CGA), working with a coalition of industries reliant on helium, urgently called for the delay in the sale of the Federal Helium Reserve System (FHR).

The FHR is located in Texas, Oklahoma, and Kansas and provides between 20 and 30 percent of the US helium supply.

The FHR sale was Congressionally mandated by the Helium Stewardship Act of 2013. CGA's successfully advocated for a delay in the 2021 sale date, and urged numerous facility issues be addressed to avoid a system shut down. We consider this to be a victory for our industry and the public and we worked hard to ensure the smoothest possible transition of the US's most important helium facility and reserves.

## **National Safety Month**

In 2023 CGA kicked off our first National Safety Month celebration.

Each week we highlighted an important theme of safety in our industry.



A cornerstone of the event was our Safety Pledge. More than 320 individuals from member companies took the pledge.

#### PLEDGE:

**C** *I pledge to prioritize safety when working with compressed gases by following all necessary precautions and guidelines to ensure the wellbeing of myself and those around me.*  *I will educate myself on the potential hazards of compressed gases and stay informed about any updates to safety regulations.* 

I will properly handle and store compressed gas cylinders and equipment, wear the appropriate personal protective equipment, and never use compressed gases or equipment in ways that are not intended. *I will encourage those around me to do the same.*
